Early deer bow kills lag after 8 weekends

Madison — Wisconsin's combined bow, crossbow, and youth gun deer harvest of 62,842 whitetails is down about 10% through the first eight weekends of the season.

There were 36,301 bucks tallied between Sept. 14 and Nov. 4, a drop from more than 41,000 bucks - and 70,027 total deer – electronically tagged between Sept. 16 and Nov. 6 last year.

Department of Natural Resources Deer Program Specialist Jeff Pritzl said the downturn surprised him after a second straight mild winter and a subpar November gun hunt last fall.

"This is purely anecdotal, but we often hear how a lot of hunters are getting choosier about what they're willing to shoot," Pritzl said.

By hunting tool type, the crossbow kill dropped from 37,027 in 2023 to 33,355 this year; the archery harvest from 25,143 to 21,753; and the youth hunt from 7,857 to 7,309. The totals don't include tribal harvest, ag damage or carkilled deer.

There were 19,840 bucks shot with crossbows, 12,484 with bows, and youth gun hunters tallied 3,789. The remaining difference in the bucks and overall season count is likely deer registered during the disabled firearm hunt, Pritzl said.

Last year's gun deer season kill

Musky Clubs Alliance offers up to \$75K to boost DNR annual stocking numbers

Alliance also bans live sonar during its annual tournament

Stevens Point, Wis. — The Musky Clubs Alliance of Wisconsin will offer the Wisconsin Department of Natural Resources (DNR) a substantial cash "gift" to mitigate proposed cutbacks in muskellunge stocking in 2025.

During their annual meeting in Stevens Point on Nov. 2, the alliance's directors authorized Bob Munsen, its liaison to the DNR's muskellunge management team, to negotiate with the DNR to provide the agency with up to \$75,000 for rearing muskies for stocking in Wisconsin waters.

The action was taken after the directors heard DNR Bureau of Fisheries Management Chief Justine Hasz and DNR District Fisheries Supervisor Tim Simonson explain the budget challenges the agency is facing and how those challenges will affect muskie stocking in coming years. The DNR's overall budget shortfall is projected to be around \$16 million in 2025, with the fisheries shortfall expected to be about \$2.5

In July, Hasz had emailed the alliance, as well as representatives of its two dozen member clubs, to let them know of proposed cutbacks

3 misdemeanors filed against woman in deer poaching case

West Bend, Wis. — A Brownsville woman allegedly involved in a southeastern Wisconsin deer poaching case faces three misdemeanor charges that could potentially result in \$22,000 in fines and two years in jail if found guilty and maximum penalties applied.

Jessica Jill Kroening, 36, of Brownsville, was charged Oct. 23 in Washington County Circuit Court with contributing to the delinquency of a child, the illegal shining of deer or bear, and obstruction of a conservation warden, according to the criminal complaint.

The charges stem from statements of three juvenile witnesses. who were also involved in the deer poaching incidents, and one adult witness. The witnesses related stories of alleged deer poaching in July and August to sheriff's department deputies, local police officers, and DNR conservation wardens.

Kroening and three 16-year-old males are alleged to have taken part in an ongoing deer poaching case over the course of roughly a year - from July 2023 through August over almost 200 square
